is an association whose aim is to bring together everyone interested in the work of the TRUST; to keep them informed of its problems and progress; and to give direct support to the TRUST by organising social and educational events for fund raising.

Membership

The subscription will entitle members to an annual lecture, and a tour of current excavation sites; to receive the TRUST'S own magazine INTERIM (optional) and to purchase TRUST publications at preferential rates. They will also elect a Council to run the Association. An annual outing will also be arranged.

The Problems

New development on old sites in York is making archaeological excavation possible on an unprecedented scale. Some areas have never before been investigated; in others, knowledge provided by earlier chance finds is being greatly extended.

To carry out the digging and many other essential tasks a continuous and reliable flow

of funds is necessary. The TRUST'S chief source of income is a grant, awarded annually by the Department of the Environment, together with smaller amounts from local government and donations to the Appeal Fund.

To augment these resources and to support and further this work the FRIENDS OF THE TRUST has been formed.

The Trust

YORK ARCHAEOLOGICAL TRUST is a professional organisation set up in 1972 to carry out RESCUE and RESEARCH excavations. It is a registered charity.

The vast amount of material and information resulting from extensive and continuous excavation needs to be analysed, recorded, conserved, researched, evaluated and finally published. The TRUST employs full-time staff qualified to deal with all these aspects of modern archaeology.

The Cost

In the three years since its inception in 1972 the TRUST'S budget has more than trebled. Rising costs of materials, salary increases and a growing number of opportunities to dig have pushed our estimated needs for 1975 up to £100,000.

If we are to investigate all available sites and maintain professional standards of work, similar sums will be needed for several future years.
